# COMPLAINT PROCEDURE FOR PROHIBITED RACIAL PROFILING

Any person who believes that an Officer has engaged in racial profiling with respect to that person shall be provided with a complaint form, which shall be available at the Caldwell Police Department. The following format has been adopted for addressing an alleged violation of Chapter 10 – Prohibited Racial Profiling in the Policy/ Procedures of the Caldwell Police Department

- 1. The Complaint should be in writing.
- 2. The complaint must be signed before a Notary Public. If the Complainant does not have access to a Notary Public, he or she may sign the form before an employee of the Department who is a Notary Public.
- 3. The complaint must be filed with the Department Coordinator (Sergeant of Patrol) of the Caldwell Police Department.
- 4. The completed form may be brought to the Caldwell Police Department located at 1105 Commerce St. Caldwell, Texas or mailed to the following address:

5. All Complaints will be investigated.
