



## **APPLICATION AND RULES FOR THE LIGHTED PARADE**

**DECEMBER 9, 2017, 6:00 p.m.**

Caldwell Main Street will host the first annual Lighted Christmas Parade on Saturday, December 9, 2017 at 6:00pm (parade will be rescheduled if there is inclement weather).

The parade will begin at the corner of Hill St. and Fox St. Parade participants will line up on Fox St. at the Caldwell First United Methodist Church beginning at 5:00 pm (no later than 5:30 pm). Main Street volunteers will check you in and assist with line-up. The parade will proceed down Hill Street to Buck Street, circle the square and head back to the Caldwell First United Methodist Church.

### **Lighted Parade Rules and Regulations:**

1. There is no entry fee.
2. Completed and signed applications must be RECEIVED by Wednesday, December 6th. Late entry will be to the discretion of the Lighted Christmas Parade Coordinator.
3. This is a family-friendly event and parade. All participants must display holiday spirit and shall incorporate the parade theme in their music, costumes, float design, and decorations.
  - a. **The theme for the parade is Christmas, the Grinch, and/or winter holiday in nature.**
4. Line up begins at 5:00pm, parade begins promptly at 6:00 pm.
5. You must check-in prior to the parade. Check-in starts at 5:00 pm at the Caldwell First United Methodist Church.
6. For safety reasons, **ABSOLUTELY NO THROWING CANDY OR ITEMS ALLOWED.** You may have designated persons to walk along the parade on the sidewalk to hand out flyers, literature, candy etc. All items being given out must be approved by Main Street before the beginning of the parade.

7. **NO LIVE SANTAS** allowed in any parade entry. There is only one Santa Claus, which is the last parade entry.
8. Both sides of floats need to be decorated.
9. All vehicles must display Christmas Decorations and/or Christmas lights.
10. No exhibitions of speed will be allowed. Please drive safely and slowly.
11. Please keep at least 10 feet from the curbs. Allow plenty of space between vehicles. Watch out for children and adults.
12. Any individuals who operate any vehicle in the parade **MUST** possess a valid driver's license.
13. The Caldwell Main Street and the City of Caldwell reserve the right to limit the number/type of vehicles and other entries in the parade.
14. No live animals.
15. All participants are expected to abide by general behavior guidelines.
16. The Caldwell Main Street and the City of Caldwell do not endorse the views, representations and behaviors of parade participants.
17. No monetary solicitations are permitted before, during or after the parade.
18. No live ammunition and/or fireworks.
19. No jumping on and off any moving vehicle.
20. Children who are walking or riding in the parade must be accompanied by an adult at all times.
21. No alcoholic beverages are allowed at the line up area or in the parade.
22. Number placement will be explained at the time of check-in.
23. Hold harmless declaration: All participants must sign a release holding The Friends of Caldwell Main Street, Caldwell Main Street, the City of Caldwell and Burleson County harmless for any loss of personal injury or property damage during the parade. Each participant or legal guardian of a minor participating must sign the release. Please feel free to copy the release form enclosed for your participants if necessary. Please assign someone to collect & turn in the releases at check in, if you do not send them in with your Entry Form.
24. Groups that appear to be participating for the purpose of protesting for or against a cause are not representative of the holiday celebration will not be allowed in the parade. The Lighted Christmas Parade Coordinator reserves the right to reject any entry which they deem inappropriate.
25. The Christmas Parade Coordinator or Main Street representative reserves the right to refuse units that are inappropriate or are not decorated to participate.
26. No abusive language will be tolerated.
